### **To Report on Matters arising**

#### **Highways**

There is to be a meeting in October "Streetcare and Highways" which is to be attended by Cllrs. Pleavin/Wells and the Clerk. We intend to raise all our concerns regarding highways issues at this meeting.

#### **Litter update**

There appears to have been a partial clean up in the lay-by adjacent to Tickeridge House after further urgent enquiries from the Clerk were sent.

There is still ongoing dialogue with CW&C and residents regarding this issue. It will also be brought up at the Streetcare & Highways Meeting in October.
