Minutes of the Meeting of the Council held on <u>THURSDAY 12 SEPTEMBER</u> 2024 at SHOCKLACH PRIMARY SCHOOL.

1.APOLOGIES FOR ABSENCE: None received.

2. DECLARATIONS OF INTEREST.

Members were invited to declare any personal, prejudicial, or pecuniary interests they may have in any item on the agenda, subject to the rules regarding disclosure contained in the current Members' Code of Conduct and as defined by regulations made under section30(3) of the Localism Act 2011.

Nothing declared.

3.PUBLIC PARTICIPATION.

i)Mobile library still very popular and a valued local service. **Resolved**: Noted.

ii)Access lane to St Ediths Church that was very potholed and in need of repair has been repaired. **Resolved**: Noted.

4.POLICE UPDATE. Police not in attendance. No report circulated prior to the meeting.

5. BOROUGH COUNCILLORS REPORT. Cllr Waddelove reported:

National Planning Policy: New framework was now out for consultation.

CWAC Children's Services: OFSTED report had been concerning with all but one area of the services requiring improvement to be good. Special Educational Needs and Disabilities (SEND): CWAC were the worst performing council in the North West for adhering to legal obligations.

There would be a reduction in CWACs services as they were £30m in debt.

The library service consultation had concluded but no report or decision was available yet.

Horton Green culvert issue was still not sorted. A bid for a culvert had been submitted and the funding put together but it needed reraising to progress.

Finance couldn't be agreed for the mobile phone mast in Tilston but it was now progressing towards the build by District Network Operator. To be sited at the back of The Carden Arms, hopefully within 6 months.

Resolved: Noted.

6. MINUTES OF THE LAST MEETING.

15. CORRESPONDENCE. Noted: Circulated on email between meetings.

i)Request re Shocklach fishing pond: Noted that the enquiry had been explored and discussed with the enquirer. No further action.

ii)Complaint re construction of road between village and St Ediths Church: **Noted**: the complaint had been forwarded to CWAC Planning and they had opened an enforcement case to investigate 24/00329/EMCOU.

11. STANDING CONSIDERATION OF HIGHWAY MATTERS.

i)Condition of road signs. Concern was expressed regarding road signs that could not be seen properly because they were dirty or old/faded. It was also noted that while signage was CWACs responsibility the hedges in some cases had spread and covered the signs and that the legal requirement was for only 1 of 2 signs to be showing. The overgrown hedges could and should be reported to CWAC and they would liaise with the landowner. Castletown Lane from Shocklach was particularly dangerous. **Resolved**: Report instances where action was required to CWAC. Cllr Waddelove would survey the Ward and rectify/address signage issues.

- ii)Path at Little Green: Update. Still waiting for action from CWAC. **Resolved**: Cllr Waddelove to chase.
- iii) Gully/drain clearing. Timing was critical and the road drains were in need of clearing thoroughly after farmers had brought the maize in to achieve maximum benefit. **Resolved:**

CWAC has an available timetable and that will only change with the administration. Blockages and floods should be reported when they happen.

12. ANY OTHER BUSINESS.

i)Defibrillator: **Noted**: Cllr Bowles advised that he continued to carry out checks and was still looking into getting paediatric pads in addition to the adult pads already available. Age of the defibrillator was discussed again and the need to remain mindful that a replacement might be needed in the potentially short-term future. Looking ahead it was suggested that maybe community fundraising might be a way of funding a replacement when necessary.

Resolved: Cllr Bowles to check the expiry date on consumables and let the Clerk know.

- ii)Councillor vacancies: **Resolved**: Cllr White to advertise in Yellow Pages again. Cllr Bowles to follow up two potential candidates.
- iii)Speed gun: **Resolved**: When the Shocklach owned gun became at cost to the Parish Council the shared Ward speed gun should be used instead.
